Message from Professor Arthur Lim



"A journey of a thousand miles begins with the first step".

Today, Asian ophthalmology is challenging the best of Europe and America. A lot of exciting developments are taking place in this part of the world. Let us work together to develop ophthalmic innovations in Asia and beyond.

How It All Began

For decades, ophthalmologists of Asia with over half the world's population, developed quality ophthalmology in the Asia-Pacific.

With independence after the Second World War, Asia improved economically and numerous eye surgeons emerged. They were anxious to do their best for Asia. What better approach than an international organisation gathering the

different countries together to prevent blindness, good clinical care and excellent surgery and foster friendships. This is the objective of the Asia-Pacific Academy of Ophthalmology (APAO).

The APAO was formed on September 11, 1958, during the 18th International Congress of Ophthalmology in Brussels. The principal objective was to foster closer ties amongst the ophthalmologists and the ophthalmological societies in the Asia-Pacific area.

There was a need to identify the geographical boundaries and these included all Asian countries (Bangladesh, Hong Kong, India, Indonesia, Japan, Korea, Malaysia, Pakistan, Philippines, Singapore, Sri Lanka, Taiwan, Thailand and Vietnam including the Pacific: Australia and New Zealand).

Asian ophthalmologists were encouraged by the President of the International Council of Ophthalmology, Sir Stewart Duke-Elder. He stated: "I know of no greater stimulus for the progress of ophthalmology in the vast area which the Asia-Pacific Academy represents than the institution of a body such as yours."

The Objectives of APAO

Congress

The main objective of APAO was having the congresses every two to four years. The meetings promoted exchanges on service, quality surgery, outcomes and research. There was an exchange of knowledge between the ophthalmic leaders of respective countries and there were improvements in the teaching and practice of ophthalmology which helped bolster our fight against blindness.

Prevention of Blindness

Another important mission of the APAO was to prevent blinding diseases. It is well known that the majority of world's blind live in Asia. A movement to galvanise international prevention of blindness organisations by APAO can help alleviate blindness in Asia by leaps and bounds. It was soon discovered that the most important blinding condition was cataract. Accordingly, cataract surgery was rapidly developed. A training centre in microsurgery and extraocular cataract extraction was established in Singapore and later in Tianjin, China, followed by similar centres in other parts of Asia.

Organisation

The organisation depended on a small group of leaders from the Asia-Pacific and national representatives who sat on the council. The most important position, Secretary-General, was reserved for an ophthalmologist who was prepared to dedicate much of his life to galvanise the leaders of different countries and to communicate with organisations and ophthalmologists in Asia and beyond so as to ensure the spread of new ideas and new knowledge throughout Asia. There was also a need to establish connections with the World Health Organisation, the International Agency for the Prevention of Blindness and the International Federation of Ophthalmological Societies.

But APAO did not have a strong financial base. It was therefore essential to have a Secretary-General who can attract – support and travel without cost to APAO as funds were not available. We thank Dr. John

Message from Professor Arthur Lim

William Holmes, the first Secretary-General of APAO, for not only his vision and commitment to use his own facilities and his own contacts to pay for and to establish important international links for the first 15 years of APAO from 1960 to 1975.

In 1976, Professor Akira Nakajima was elected the Secretary-General. He too continued as Secretary-General with talent and dedication, and ran the organisation with funds raised from his university and supporters. In 1990, he relinquished his position to me who also chaired International Congress of Ophthalmology (organised by the International Council of Ophthalmology) held in Singapore in the same year. It was one of the most successful world congresses held.

I am honoured to lead APAO for 15 years and in 2006, Professor Dennis Lam, a young dynamic Professor for Ophthalmology at the Chinese University of Hong Kong, took over as Secretary-General.

More than half a century has passed since the momentous evening when Dr. William Holmes, Dr. Geminiano de Ocampo, Dr. Jesus Tamesis, Dr. Angelo and Dr. Robert Lowe drafted the first Constitution of the Asia-Pacific Academy of Ophthalmology (APAO) following a dinner in the Manila Hotel in October, 1958. Our APAO Congresses have gradually established itself as the key one-stop platform for all ophthalmic training and educational needs for eye care professionals in our region. The APAO Awards have identified and honored those individuals who have made exemplary contributions to the development of ophthalmology and the promotion of eye care. Our Awardees continue to set excellent examples for the rest of us to follow.

Looking ahead, we have important new initiatives that will further expand the role of APAO in regional ophthalmic training and education. As the Secretary General of the APAO, it is my greatest privilege and pleasure to share with you some of these new developments.

The **APAO Fellowship Program** aiMs. to help promising young ophthalmologists from developing nations broaden their skills, knowledge, and experience in clinical ophthalmology, especially in areas of greatest relevance to their home institutions and countries. Fellows are expected to bring their acquired knowledge and skills back to their native countries and participate in blindness-prevention programs. Fellowships will be offered in comprehensive ophthalmology as well as in subspecialties, such as pediatric ophthalmology, medical and/or surgical retina, cataract surgery, cornea & external diseases, glaucoma, neuro-ophthalmology, ocular oncology, uveitis, and strabismus.

The **APAO Online Education Program** aiMs. to bring virtual ophthalmic training and education to the eye care professionals in developing regions, through uploaded seminars and grand rounds, ophthalmic photo and video libraries, and online expert discussion forums. Modern technologies allow us to provide training and education of the highest caliber to distant corners of the world very cost effectively and on a continuous and sustainable basis.

The official **APAO Journal** aims, on the one hand to showcase the best research work from the region, and also top-notched publications of greatest relevance to the region; on the other hand, it targets at building this into an international platform for publication of first class research from around the world. The APAO Leadership Development Program aiMs. to identify and nurture the future leaders of the ophthalmic communities of our region. Through self-initiated community and healthcare projects, our younger generations learn to identify needs, organize local projects, and to shoulder professional

responsibilities. The fraternity arising from this program also allows our future ophthalmic leaders to commence lifelong friendships and collaborations at an early stage of their careers.

History

Like all great institutions, it all started as one man's dream - that of William John Holmes.

Dr. Holmes was born in Budapest, crossed the Atlantic emigrated to America in the 1920s, and eventually practiced ophthalmology in the middle of the Pacific Ocean in Hawaii! Hawaii at that time, although a territory of USA, was not yet its 50th state (that came later in 1959). Dr. Holmes allowed his thoughts to turn eastward towards the ancient continent when he called for Asian leaders of ophthalmology to unite in the 1950s. As he noted later (in his address at the second APAO Congress), "the idea for the organisation of the Asia-Pacific Academy of Ophthalmology grew out of the realization that eye surgeons in the neighbouring countries of Asia, Australasia, and Oceania were faced with identical ophthalmological problems".

A response to his call came in September 1958. At the 19th International Congress of Ophthalmology in Brussels, a decision was made to form the Asia-Pacific Academy of Ophthalmology. One month later, the indefatigable Dr. Holmes journeyed to the Phillipines. Following a dinner at the gracious environs of the Manila Hotel, Dr. William J Holmes, Dr. Geminiano de Ocampo (Philippines), Dr. Jesus Tamesis (Philippines), Dr. Angelo and Dr. Robert F. Lowe (Australia) drew up the Constitution of the Academy and paving the way for the first meeting of the Academy in Manila on 10 - 13 October 1960.

History

The first Academy and Congress President was Dr. de Ocampo, the "Father of Modern Phillipine Ophthalmology". The Academy was formed with the principal objective of fostering closer relations among ophthalmologists and ophthalmology societies in the Asia-Pacific region to fight against blindness. It serves today as a platform to promote the prevention of blindness and restoration of sight through service, research and teaching in ophthalmology. Other objectives are to encourage the free exchange of ophthalmic knowledge and the advancement of the standard of eye care through the hosting of regional congresses or other conferences. More importantly, the APAO is entrusted with forming a family of ophthalmology societies for the welfare of all peoples and nations of the region.

Initially the first four APAO Congresses were held every four years. Since 1972, the Congresses were organized every two years. To meet the growing demand for more frequent interactions in a fast changing world, the APAO Congresses will now be held annually, starting from 2006 in Singapore.

The Asia-Pacific region is home to more than half the world's population and also more than half the visually handicapped in the world. Quite obviously the ophthalmologists of the Asia-Pacific area have an enormous task on their hands. They have proved in the past 50 years that they are well up to this daunting task.

At present, APAO has 19 member organizations from different countries and tariff territories of the Asia-Pacific regions, including Australia and New Zealand, Bangladesh, China, Chinese Taipei, Cambodia, Hong Kong, India, Indonesia, Japan, Korea, Malaysia, Mongolia, Nepal, Pakistan, Philippines, Singapore, Sri Lanka, Thailand and Vietnam.

APAO has come a long way since 1960. Its raison d'etre is best described in the words of that legend of ophthalmology, Sir Stewart Duke-Elder, in his message to the first APAO Congress in 1960, when he was President of the International Council of Ophthalmology, "I know of no greater stimulus for the progress of ophthalmology in the vast area which the Asia-Pacific Academy represents than the institution of a body such as yours".

A) Introduction

The Royal Australian and New Zealand College of Ophthalmologists (RANZCO) is the professional body representing more than 1000 ophthalmologists in Australia and New Zealand.

Its mission is the improvement of the already high standard of eye care which exists in the two countries. In pursuit of this goal, it provides a variety of services centred on its core roles as a higher educational institution and learned society.



The College's services cover the total spectrum of eye care delivery, from the promotion of scientific research through to the training of specialists and lifelong support for service delivery and patient care.

Apart from activities in mainstream Australia and New Zealand, the College and its members participate independently and collectively, in a variety of eye care programs. In conjunction with other agencies and Governments, programs are designed to assist particular groups, such as indigenous peoples and those living in rural and regional areas and also overseas in countries such as Papua New Guinea, Fiji, India, Vietnam, China, Vanuatu, East Timor, Bali, Western Samoa, Myanmar, Afghanistan, Sri Lanka, Cambodia, Solomon Islands and Tuvalu.

Among RANZCO's affiliated organisations are the Ophthalmic Research Institute of Australia (ORIA), the RANZCO Eye Foundation and the Save Sight Society of New Zealand.

The College is a gold member of Vision 2020 Australia and a member of the International Council of Ophthalmology and the International Agency for the Prevention of Blindness.

The College's Annual Scientific Congresses - usually held in November - are renowned for their quality of scientific content. They attract about 1000 doctors from Australia and New Zealand, other parts of the Asia-Pacific Region and other overseas countries.

Indonesian Ophthalmologists Association

A) Introduction

The Indonesian Ophthalmologists Association (IOA) or PERDAMI (Persatuan Dokter Spesialis Mata Indonesia) is the only professional organization of ophthalmologists in Indonesia. IOA was founded in Jakarta on July 5, 1964,



aimed to promote eye health of Indonesians, and the development of ophthalmology in Indonesia. The IOA is responsible in improving the competence of Indonesian ophthalmologists, in line with the advances in science and technology, moreover, to support the social well-being of IOA members.

Currently, there are 15 IOA' chapters, with a total of 1070 IOA' members, consisting of ophthalmologists who are Indonesian citizens, and 571 ophthalmology residents in training, and several others who are regarded as having special contributors in ophthalmology and eye healthcare in Indonesia.

In orders to facilitate the widening professional horizon and creating atmosphere for research, the IOA since the year 2000; conducted a posters, free papers, and scientific quiz contests during the every Annual Meeting. The first winners of its category are rewarded a free tuition fee, transportation and boarding plus US \$ 200 for courses to attend the APAO congress (formerly to the AAO meeting). The second winners get a similar grant minus the courses fee. In order to facilitate the research atmosphere, we have granted US \$ 500 for every publication in the cited' International Ophthalmology Journals.

The spearheads of sub-specialities development are held by the 8 (eight) Specialities Interest groups, namely the Cataract & Refractive Surgery (InaCRS), the Vitreo-Retinal, Glaucoma, Refractive & Contact Lenses, Infection and Immunology, Pediatric Ophthalmology & Strabismus, Ocular Oncology & Oculoplastic, Neuro-Ophthalmology, and Community Ophthalmology.

We are fully aware to the fact that Indonesia, the fourth most populated country, has a high rate of blindness (1.5%). The Department of Public Service' has been putting its continuous effort in working closely with the government, numerous international and national non-governmental organizations, and companies, to incorporate resources in projects to prevent blindness and eye probleMs. in Indonesia. Cataract is the main cause of blindness in Indonesia (more than 50%), and is more prevalent among the low economics patients. Since 1996, the IOA has been conducting Charity Cataract Surgeries nationwide, coordinated by Cataract Blindness Prevention Section. However, the total surgeries number are directly in line with the funds availability. This Charity Cataract surgeries has a dual targets, declining the Blindness Rate and as training and maintaining the surgical skills either for the residents and or the eye doctors. Moreover, the IOA' has also awarded a grant to attend the APAO meetings to whom who have conducted the highest numbers of cataract surgery during the Charity Cataract Events in the previous year. Advocacies, fund raising activities and services for other eye health probleMs. such as uncorrected refractive disorders, glaucoma, diabetic retinopathy, and childhood blindness, are other issues in IOA's agenda.

IOA has co-organized and participated in regional and international ophthalmology events, including being host in two APAO congresses (in 1976 and 2009), conducting a joint meeting with the APACRS (2003 and 2007), and hosting the ORBIS Flying Eye Hospital Program in 1982 and 2010.

Japanese Ophthalmological Society

A) Introduction

The first professor of Ophthalmology in Japan was Jujiro Komoto, who returned from Germany to the Tokyo Imperial University in 1889. In 1897, Takuji Suda, Yoshiakira Ohnishi and Genjiro Kawakami established the Japanese Ophthalmological Society (JOS) and invite Professor Komoto to be the first president. The JOS is the second oldest medical society in Japan, only after the Japanese Association of Anatomists. Since then, a general meeting has been held annually. The JOS celebrated its centennial anniversary in 1996. Famous



members of the JOS include Mikito Takayasu, the first to describe Taakyasu's disease; Chuta Oguchi (Oguchi's disease), Yoshizo Koyanagi (Vogt-Koyanagi disease), Einosuke Harada (Harada disease), Akira Urayama (acute retinal necrosis, Kirisawa-Urayama uveitis), as well as Tatsuji Inoue who first reported the relation between the visual field and its projection to the occipital lobe, and Shinobu Ishihara who developed the pseudo-isochoromatic plates for color blindness.

The current major activities of the JOS include the followings:

- i) Organizing the annual meeting of the JOS and the annual congress of Japan Clinical Ophthalmology;
- ii) Publishing the Japanese Journal of Ophthalmology (in English) and the Journal of JOS (in Japanese);
- iii) Fostering and advancing ophthalmology;
- iv) Supporting research/investigation of ocular diseases;
- v) Holding public lectures;
- vi) Communicating and collaborating with related academic societies both at home and abroad;
- vii) Certifying diplomates of Ophthalmology and other matters;
- viii) Promoting the lifelong education of diplomats;
- ix) Promoting activities relating to organ transplantation;
- x) Other activities that promote the advancement of ophthalmological medicine.

The JOS hosted the 23rd International Congress of Ophthalmology, 1978, in Kyoto and the 13th Congress of the Asia-Pacific Academy of Ophthalmology, 1991, in Kyoto, and is going to host the 34th World Ophthalmology Congress, 2014 in Tokyo and the 29th Congress of the Asia-Pacific Academy of Ophthalmology, 2014, in Tokyo.

The first academic meeting of the KOS was successfully held in Seoul in 1949. In 1958, the society published its first journal The Journal of The Korean Ophthalmological Society in Korean. In 1987, the society also began publishing The Korean Journal of Ophthalmology



(Korean J Ophthalmol) which is currently the official English journal of the KOS. The entire text of the Korean Journal of Ophthalmology has been made accessible through Pubmed, and will be registered in SCI (Scientific Citation Index) shortly. Furthermore, in 1973, the Korean Foundation for the Prevention of Blindness was established.

The KOS holds two national academic meetings biannually in the spring and fall along with numerous regional meetings throughout the year. The KOS agreed to designate November 11 as the National Eye Day. During this week, free eye checkups, educational programs, and special activities are provided to the public.

The KOS has also successfully hosted many international conferences. In 1989, the 12th Congress of the Asia-Pacific Academy of Ophthalmology (APAO) was held in Seoul with 1,200 delegates, of which 550 are from foreign countries. Some of the international meetings held include, The Third Congress of Asia Oceanic Glaucoma Society (AOGS) in 2001, The First Asian Angle-Closure Glaucoma Club (AACGC) conference in 2002, SEAGIG-AACGC Joint Congress in 2008, The Third Congress of Asia-Pacific Vitreo-Retinal Society (APVRS) in 2008, and The 5th International Meeting on Advanced Cataract and Refractive Surgery (IMACRS) in 2009. Through these meetings, the KOS has not only developed academically but contributed in promoting active exchange among ophthalmologists throughout the world. As part of that effort, The 27th Asia-Pacific Academy of Ophthalmology (APAO) Congress is planned to be held in Busan in 2012.

The beginning of the 21st century has brought rapid development in every ophthalmological field within the KOS. We hope that he KOS will become even more internationally recognized through continual academic as well as clinical activities in order to further contribute to the field of ophthalmology.



A) Introduction

The College of Ophthalmologists of Sri Lanka is the only professional body of ophthalmologists in the country. It is the direct continuation of the Ophthalmological Society of Sri Lanka founded in 1957. It was established in 1991 and the office of the College is presently functioning at the National Eye Hospital, Colombo, which is the centre of excellence and the main training centre for ophthalmic post graduate trainees, ophthalmic technologists and ophthalmic nurses.

The Ophthalmological Society of Ceylon was formed by a group of interested clinicians who met at Victoria Memorial Eye Hospital on 1 December 1957 and was the second oldest Specialist Association in the country. Dr. WHD Ferdinands was the Founder President.

The first Annual Congress of the society was held in 1958 September at the Medical Research Institute, Colombo. Ophthalmologists from the Asia-Pacific Academy attended this congress. In keeping with the increasing academic demands of the Post Graduate Institute of Medicine, University of Colombo and the advancement of ophthalmic care in the country, the need for the formation of a college was felt and the College of Ophthalmologists of Sri Lanka was formed in 1991 with Dr. P. Sivasubramaniam as its Founder President. In 1992 Dr. P. Sivasubramaniam was inducted as the Founder President of the College.

The Journal of the College of Ophthalmologists of Sri Lanka was initiated with the formation of the College and the printing of the first edition was in 1993. It had two Editors, Dr. P. Sivasubramaniam being the Founder Editor. From 2001 the publication of the journal is done every six months to date. This is a peer reviewed journal.

The founder president Dr. P. Sivasubramaniam passed away when he was 86 years old in December 2002. The Dr. P. Sivasubramaniam Oration is delivered every year from the year 2003 by invitation. The Oration is dedicated to the memory of the most revered ophthalmologist of Sri Lanka.

The College successfully conducted the VIIth and VIIIth SAARC Ophthalmological Congresses with the Annual Scientific Sessions in 2000 and 2006.




The main purpose of the Congress is not only to bring ophthalmologists in the Asia-Pacific Region together, but also to promote recent advancement in ophthalmology.













Professor Yasuo Tano Travel Grant



The sudden passing of Professor Yasuo Tano on January 31, 2009 in Osaka at the age of 60 shocked the entire ophthalmic community in the world. His departure is a huge and sorrowful loss to his family, patients, students, and friends, and to both eye care professionals and eye disease sufferers worldwide.

Professor Tano was a vitreo-retinal specialist and the Chair Professor of the Department of Ophthalmology of Osaka University Medical School. His leadership has been pivotal in the development of ophthalmology in not just Japan and Asia-Pacific region but all over the world. He played very key and active roles in many international and regional ophthalmological societies. Amongst his key

responsibilities, he was the Treasurer of International Council of Ophthalmology (ICO), the President of Asia-Pacific Academy of Ophthalmology (APAO), and the Founding President of Asia-Pacific Vitreo-Retina Society (APVRS).

Professor Tano's achievements were phenomenal and his impact worldwide. His great leadership had inspired generations of ophthalmologists and eye care professionals in the Asia-Pacific region and beyond. Professor Tano will always be remembered as a person of great integrity, a caring eye specialist, an outstanding surgeon, a dedicated teacher, an accomplished researcher, and a prolific writer. His immense contributions to vitreo-retinal surgery, and his highly acclaimed leadership in international ophthalmology, will be fondly remembered by generations of ophthalmologists to come.

With the aims to support young ophthalmologists to attend APAO annual congresses, to enable them to equip themselves with update knowledge and technique, APAO has decided to establish the Professor Yasuo Tano Travel Grant in 2009 to continue Professor Tano's spirits and contributions to the ophthalmology society.

The set up of the Professor Yasuo Tano Travel Grant is to memorize this important leader of us, and more importantly, with his remains cremated and his soul left for the field, his role-modeling is to remain forever.

The Road Ahead

When APAO was founded in September 1958, no one could have imagined how much the ophthalmic community in the Asia-Pacific region would have achieved in the ensuing five decades. The APAO Fellowship Board will stay in close contact with the APAO Host Institutes and the Fellows during their Fellowship in order to ensure the best possible training for the Fellows. Fellowships will be offered in comprehensive ophthalmology as well as in subspecialties, such as pediatric ophthalmology, medical and/or surgical retina, cataract surgery, cornea & external diseases, glaucoma, neuro-ophthalmology, ocular oncology, uveitis, and strabismus. The relevance of the training programs to the candidates' home institutions and countries is of special importance.

In addition to the APAO Fellowship Program, modern online technologies may also play a key role in allowing developing regions to benefit from the ophthalmic expertise, training and education provided by the leading institutions within the Asia-Pacific or around the world. The **APAO Online Education Program** aims to bring virtual ophthalmic training and education to the eye care professionals in developing regions, through uploaded seminars and grand rounds, ophthalmic photo and video libraries, and online expert discussion forums. Modern technologies allow us to provide training and education of the highest caliber to distant corners of the world very cost effectively and on a continuous and sustainable basis. Both the APAO Fellowship Program and the APAO Online Education Program will make major synergistic contributions, in terms of training and education, to the efforts of the **APAO Prevention of Blindness Program**.

The Road Ahead

Apart from helping less privileged countries to provide adequate basic ophthalmic care, APAO continues to play a key role in providing the right environment for leading ophthalmic centers within the Asia-Pacific region to reach even greater heights and international acclaim. The official **APAO Journal** aims, on the one hand to showcase the best research work from the region, and also top-notched publications of greatest relevance to the region; on the other hand, it targets at building this into an international platform for publication of first class research from around the world. It has for so long been the dream of many of our forefathers to have a top international ophthalmology journal that we can call our own, with special emphasis on diseases, treatments and healthcare issues that are of greatest importance to our region.

Long-term regional developments depend on visionary leaders. The **APAO Leadership Development Program** was established in 2009, with the aim of identifying and nurturing the future leaders of the ophthalmic communities of our region. Through self-initiated community and healthcare projects, our younger generations learn to identify needs, organize local projects, and to shoulder professional responsibilities. The fraternity arising from this program also allows our future ophthalmic leaders to commence lifelong friendships and collaborations at an early stage of their careers.

There are no doubt abundant challenges and opportunities along the road ahead, many of which we cannot possibly imagine here and now. 


